Dear Shareholder,

We are writing to inform you of the following changes to the Mirae Asset Asia Sector Leader Equity Fund and Mirae Asset Asia Great Consumer Equity Fund (collectively, the “**Sub-Funds**”), sub-funds of the Mirae Asset Global Discovery Fund (the “**Company**”).

### **Increase of aggregate exposure to China A-Shares and/or China B-Shares and direct investments in China A-Shares through Stock Connect**

Currently, the Sub-Funds’ direct investments in China A-Shares through Stock Connect shall not exceed 10% of their respective net assets. With effect from 11 June 2018, the Sub-Funds’ direct investments in China A-Shares through Stock Connect have been increased and shall not exceed 25% of their respective net assets.

The Sub-Funds may also make indirect investments in China A-Shares via access products. Currently, in aggregate, the Sub-Funds’ investments in China A-Shares (through direct and indirect investment) and/or China B-Shares shall not exceed 10% of their respective net assets. With effect from 11 June 2018, the aggregate exposure of the Sub-Funds’ investment in China A-Shares (through direct and indirect investment) and/or China B-Shares has been increased and the Sub-Funds in aggregate, may invest less than 30% of their respective net assets in China A-Shares (through direct and indirect investment) and/or China B-Shares.

### **Update of Hong Kong offering documents**

The existing Hong Kong offering documents (comprising the Prospectus of the Company dated January 2018, the Information for Hong Kong Investors and the Product Key Facts Statement of each Sub-Fund) (where applicable) will be amended to reflect the above changes and will be available free of charge from Mirae Asset Global Investments (Hong Kong) Limited, Principal Investment Manager

of the Company and on the website <http://investments.miraeasset.com.hk> in due course. Please note that the website has not been reviewed by the SFC.

To the best of the knowledge and belief of the Board of Directors (who has taken all reasonable care to ensure that such is the case), the information contained in this notice is in accordance with the facts and does not omit anything likely to affect the import of such information as at the date of this notice.
